The Institute of Company Secretaries has come up with a unique initiative “Shaheed ki Beti” which was launched on 4th October 2017 on the commemoration day of Golden Jubilee Celebration of the Institute. Under this scheme, the Institute will be providing financial support to the girl child of the martyrs for her higher education or for any other purpose. To financially support the girl child of the martyrs, ICSI will be presenting a beautifully designed and printed certificate to the dignitaries / guest / faculty and practice of presenting the memento to dignitaries/ guest/ faculty shall be discontinued. The Institute will determine the total number of such certificates issued in a year on pan India basis and total amount accumulated in this fund will be donated to any girl child of martyrs as financial support from ICSI to “Shaheed ki Beti”.
