ABOUT THE CONFERENCE

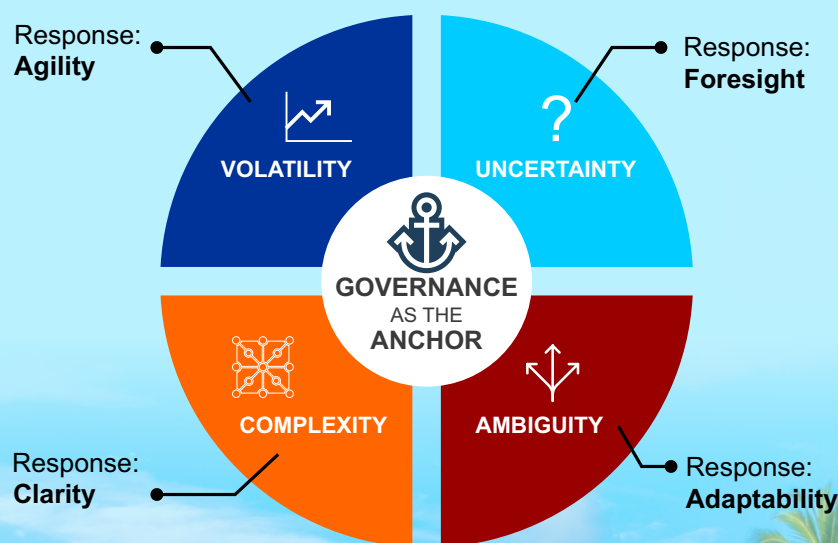

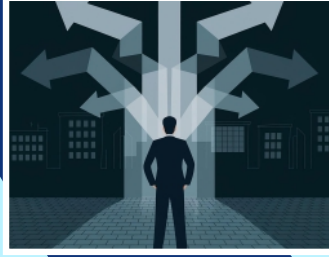
