Independent Directors (IDs) are in the limelight after the implementation of Companies Act, 2013. Recently, after the break out of some of the largest corporate scams in the country and the subsequent increase in the number of resignations by IDs, there is a heightened focus on their role and responsibilities as custodians of stakeholders' interests. The corporate governance structure hinges on the IDs, who are supposed to bring objectivity to the oversight function of the board and improve its effectiveness.

However, the current legislation framework does not differentiate between IDs and Executive Directors (EDs) as it fails to distinguish between their liabilities. Therefore, the need of the hour is for the legislature to draw a line between IDs and EDs by defining their roles and responsibilities, and demarcating their liabilities. Raising the appropriate red flags at the right time would also help IDs in avoiding the occurrence of unwanted situations and their consequences to a great extent.
