About Kochi

Kochi, formerly known as Cochin, is a vibrant coastal city nestled along Kerala's scenic Malabar Coast. Nicknamed as the "Queen of the Arabian Sea", this port city has been a hub of maritime trade and cultural convergence. Kochi wears many crowns - it is the 'Commercial Capital of Kerala', the 'Gateway to Kerala', and a beacon of sustainable innovation, proudly hosting India's first water metro and the world's first airport powered entirely by solar energy.

Kochi is one of the fastest growing second-tier metros in the country and is now home to several industrial parks. The industrial parks have state-of-the-art facilities to cater effectively to the needs of various industry verticals such as IT, tourism, engineering, garment production, food processing, rubber production, etc.

Its cultural landscape is just as remarkable. Centuries of global connections and local heritage have shaped Kochi into a melting pot of traditions and communities. Kochi is known for its cultural diversity, which is reflected in the city's festivals, religious landmarks, and culinary traditions.

How to reach Kochi



By Air: India's first solar powered airport, Cochin International Airport will give you a green welcome into the city. All major domestic carriers as well as some International carriers have flights to Kochi. The airport is located 29 kms away from the main city. Distance from Convention Venue is about 33 Kms.



By Train: Most Kerala bound trains from across the country have a stop at Kochi. There are two main terminals in the city, the Ernakulam Junction and the Ernakulam Town. A rail journey to Kochi will leave you spellbound by the beautiful view of the Ghats (hills) during your journey. Distance from Convention Venue is about 7 Kms.



By Road: Kochi is well-connected with national highways and is a part of the North-South Corridor of India's National Highway System. The city has a very fast and efficient bus transport system. Kochi bus stand is situated at the center of the city. Distance from Convention Venue is about 5 Kms.



Tourist Attractions

Kochi Water Metro

Kochi Water Metro is a ferry transport system serving the Greater Kochi region in Kerala. It is the first water metro system in India and the first integrated water transport system of this size in Asia. When fully operational, it will connect Kochi's 10 island communities with the mainland through a fleet of 78 battery-operated electric hybrid boats operating along 38 terminals and 16 routes spanning 76 kilometres. It is integrated with the Kochi Metro and serves as a feeder service to the suburbs along the rivers where transport accessibility is limited.

Distance from Convention Venue: About 2.7 Kms.



Sunset Cruise

A sunset cruise in Kochi offers a relaxing way to experience the city's waterfront and enjoy the beauty of the Arabian Sea at sunset. These cruises typically depart from Marine Drive and last for about two hours, allowing passengers to witness the sun setting over the horizon.

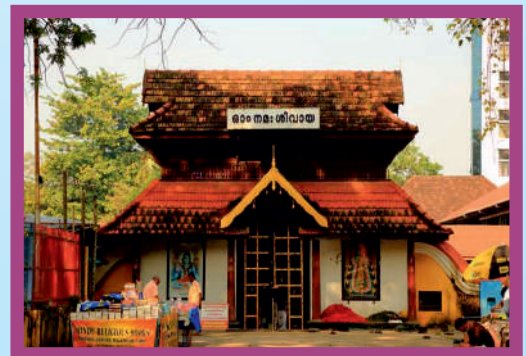
Distance from Convention Venue: About 3.3 Kms.



Ernakulam Shiva Temple

Ernakulam Shiva Temple, also known as Ernakulathappan Temple, is one of the major temples of Kerala, located in heart of Ernakulam. The temple, dedicated to Lord Shiva, is considered as the city temple, with the presiding deity as the protector of the city.

Distance from Convention Venue: About 4.5 Kms.



Kochi-Muziris Biennale

The Kochi-Muziris Biennale is a contemporary art exhibition held in Kochi, Kerala. It is the largest art biennale in India and one of the biggest in Asia.

Distance from Convention Venue: About 5.1 Kms.



Santa Cruz Basilica

Santa Cruz Basilica is one of the finest and most impressive churches in India, attracting tourists year-round. Originally built by the Portuguese in 1505, it is not only a place of devotion but also a center of historic significance, endowed with architectural and artistic grandeur.

Distance from Convention Venue: About 6 Kms.





Fort Kochi

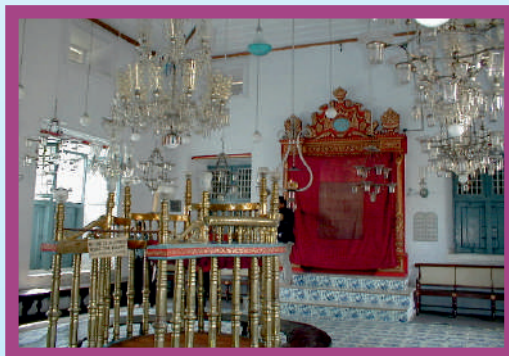
Fort Kochi traces its roots back to the first European fort on Indian soil. Established by the Portuguese East Indies, this coastal gem forms part of the Old Cochin or West Cochin, a cluster of water-bound islands and islets nestled southwest of mainland Kochi. It is rich in heritage and culture and is a prominent tourist destination.

Distance from Convention Venue: About 7 Kms.

Jew Town

Historic Jew Town, the heart of the once-thriving Cochin Jewish community, is known for its old-world charm and 16th century Paradesi Synagogue. Quaint shops around Synagogue Lane and Jew Town Road sell antiques, carvings, and vintage collectibles, along with Keralan crafts and aromatic spices. Laid-back outdoor cafes and artsy eateries, some in heritage buildings, serve local specialties and Western fare.

Distance from Convention Venue: About 7.2 Kms.



Jewish Synagogue

The Jewish synagogue was built in 1568, almost 1500 years after the beginning of the Jewish connection with Kerala. It was built on the land, adjacent to the Mattancherry Palace, given by the erstwhile king of Cochin. The synagogue, the oldest in the Commonwealth, was built by the Jewish community of Cochin.

Distance from Convention Venue: About 7.5 Kms.

Mattancherry Palace or Dutch Palace

Mattancherry Palace also known as the Dutch Palace was originally built by the Portuguese in the 16th century and later renovated by the Dutch, hence the dual name. The palace is renowned for its Kerala-style architecture with European influences and its collection of murals depicting scenes from the Ramayana and other Hindu Puranas.

Distance from Convention Venue: About 15 Kms.



Hill Palace Museum

Perched atop serene hills in Kochi, the Hill Palace Museum is a proud testament to the opulence, history and rich cultural heritage of the land. This architectural marvel unfolds a saga of royalty and legacy that offers a glimpse into the bygone era of the Maharajas of Kochi.

Distance from Convention Venue: About 16 Kms.





Chottanikkara Bhagavathy Temple

This temple is the most important temple among the 393 shrines spread over 3 Districts of Kerala and coming under the administration of Cochin Devaswom Board. The Divine Mother known as Rajarajeswari (Adiparasakthi) is worshipped here in three forms Saraswathy in the morning, Lakshmi at noon and Durga in the evening. There is an Idol of Mahavishnu on the same pedestal and so the Deity is called Ammenarayana, Devinarayana, Lakshminarayana and Bhadrenarayana also. Along with Lakshmi & Narayana there are idols of Brahma, Siva, Ganapathi (Ganesh), Subramanya and Sastha on the same pedestal.

Distance from Convention Venue: About 20.2 Kms.



Cherai Beach

Towards the north of the Vypeen islands lies Cherai Beach, a true swimmer's paradise. A pristine canvas where nature weaves its magic through golden sands, azure waters and lush greenery, Cherai Beach is widely considered to be a gem in the crown of Kerala's coastal treasures.

Distance from Convention Venue: About 25 Kms.

Wonderla Amusement Park, Kochi

Wonderla Kochi is the largest, craziest, and most amazing part of town. India's first amusement park, is a 35-acre wonderland with over 50 thrilling rides for all ages. It is a heaven of fun, safety, and eco-friendliness, certified by ISO 14001 and OHSAS 18001.

Distance from Convention Venue: About 27.3 Kms.



Kalady

A village named Kalady, meaning 'feet' in Malayalam, is located on the banks of the Periyar river. An important Hindu religious destination, it is famous as the birth place of Adi Sankara, the founder of the Advaita order.

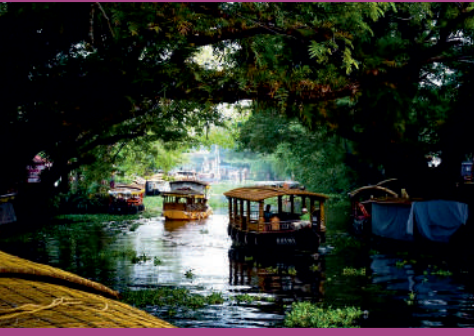
Distance from Convention Venue: About 37 Kms.

Kumarakom

Kumarakom is a village on Vembanad Lake in the backwaters of Kerala. It is laced with canals, where houseboats ply the waters. Kumarakom Bird Sanctuary is home to many species including cuckoos and Siberian storks. Nearby, the Bay Island Driftwood Museum displays wooden sculptures. In the lake, Pathiramanal Island is a heaven for rare migratory birds. Ancient Thazhathangady Mosque is to the east of Kumarakom.

Distance from Convention Venue: About 55.9 Kms.





Alleppey

Alappuzha (or Alleppey) is a city on the Laccadive Sea in Kerala. It is best known for houseboat cruises along the rustic Kerala backwaters, a network of tranquil canals and lagoons. Alappuzha Beach is the site of the 19th century Alappuzha Lighthouse. The city's Mullakkal Temple features a traditional design. Punnamada Lake's snake boat races are a well-known annual event.

Distance from Convention Venue: About 66.2 Kms.

Athirappilly Falls

Athirappilly Falls are situated in Thrissur District of Kerala on the Chalakudy River. Athirappilly Falls is the largest waterfall in Kerala and is nicknamed as 'The Niagara of South India'. The falls attract visitors from across India, especially during the monsoon months.

Distance from Convention Venue: About 67 Kms.



Guruvayur Sri Krishna Temple

Guruvayur Sri Krishna Temple, located in the town of Guruvayur in Thrissur district of Kerala, is one of the most revered and popular temples dedicated to Lord Krishna. Known for its rich cultural heritage, religious significance, and architectural beauty, Guruvayur Temple attracts millions of devotees and tourists from across the country and around the world.

Distance from Convention Venue: About 85 Kms.



Munnar

Munnar is a town in the Western Ghats mountain range in Kerala. A hill station and former resort for the British Raj elite, it's surrounded by rolling hills dotted with tea plantations established in the late 19th century. Eravikulam National Park, a habitat for the endangered mountain goat Nilgiri tahr, is home to the Lakkam Waterfalls, hiking trails and 2,695m-tall Anamudi Peak.

Distance from Convention Venue: About 127 Kms.



Thekkady

Thekkady in Kerala, India's largest wildlife sanctuary is a dream destination for any tourist visiting India. The 120 years old 'Surki' dam built across Peryar, Poorna in Vedic parlance, is a major tourist attraction. This sanctuary is spread over an area of 777 Sq.Kms, surrounded by an artificial lake over an area of 25 Sq.Kms. The Country's sole Tiger reserve, Thekkady, with its bountiful treasures of tropical flora and fauna is the ultimate reservoir of many endangered species and a rich tribal culture. Thekkady is a pleasant heaven on Earth for those who love nature in its wild manifestations.

Distance from Convention Venue: About 149 Kms.





Varkala

Varkala is a town in Kerala on the Arabian Sea and known for Varkala Beach, backed by palm-covered red cliffs. Just south, Papanasam Beach is believed to have holy waters. On a nearby hill, the ancient Janardanaswamy Temple is a Hindu pilgrimage site dedicated to Lord Vishnu. Farther inland, the Sivagiri Mutt monument memorializes the social reformer Sree Narayana Guru, who is buried here.

Distance from Convention Venue: About 189 Kms.

Sree Padmanabhaswamy Temple

Sree Padmanabhaswamy Temple is located at Thiruvananthapuram. Dedicated to Lord Vishnu, the temple is one among the 108 Divya Desams (the most sacred of Vishnu temples) in India. A striking feature of the temple is the Ottakkal Mandapam in front of the main sanctum which is built out of a single slab of granite and its pillars covered by gold.

Distance from Convention Venue: About 225 Kms.



Kovalam

Kovalam is a small coastal town in Kerala, south of Thiruvananthapuram. At the southern end of Lighthouse Beach is a striped lighthouse with a viewing platform. Palm-backed beaches also include Hawa Beach and Samudra Beach. Heading south, Vizhinjam Juma Masjid mosque overlooks the busy fishing harbor. Inland, Sagarika Marine Research Aquarium displays technology used in pearl production.

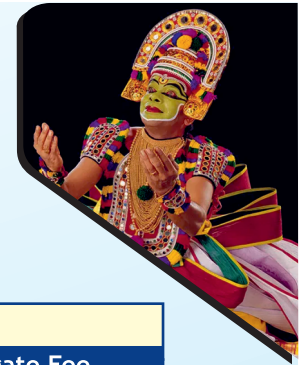
Distance from Convention Venue: About 236 Kms.

Wayanad

Wayanad is a rural district in Kerala. In the east, the Wayanad Wildlife Sanctuary is a lush, forested region with areas of high altitude, home to animals including Asiatic elephants, tigers, leopards and egrets. In the Ambukuthi Hills to the south, Edakkal Caves contain ancient petroglyphs, some dating back to the Neolithic age.

Distance from Convention Venue: About 258 Kms.

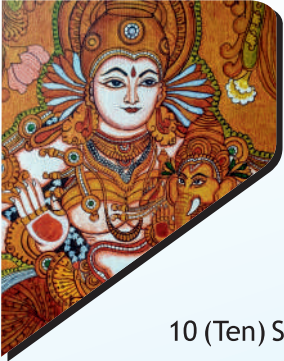

Hotel Accommodation for Delegates

1. The members/students/others (as the case may be) are required to first get themselves registered as delegate for the 53rd National Convention of Company Secretaries.
2. The ICSI has taken best/ negotiated rates from some of the hotels and blocked the rooms at concessional rates for delegates attending the National Convention. The delegates are requested to avail this opportunity at the earliest.
3. For booking of rooms in hotels, delegates may select the hotel as per their choice from the list of hotels given below. They may download the room booking form from the link given against that hotel's name. Delegates need to fill-up details including the Delegate Reference No. in the form and scanned copy of the same is required to be forwarded by e-mail to respective Hotel. Upon receipt of the same, the hotel shall share the link for payment and accordingly, delegates may make the payment and book the rooms.
4. All payments related to hotels are to be settled by the delegate with the hotel concerned directly.
5. All delegates may kindly note that hotel rooms shall be booked on full occupancy basis. The sharing of the room with the other delegate is permissible and will depend completely on the mutual understanding amongst the delegates. The details of the accompanying delegate are to be filled in the form at the time of booking of the hotel. The ICSI in no way is involved in the process and would not be suggesting any names for sharing of room.
6. Hotel may allow delegates for early check-in, if some of them are reaching before check-in time. But this facility is subject to availability of rooms at that point of time. Lunch is arranged to be served from 12:00 Noon onwards (on Day 1) at Convention Venue to facilitate such delegates who are reaching Kochi before check-in time of their respective hotels.
7. Delegates are free to book their stay in any hotel of their own choice.
