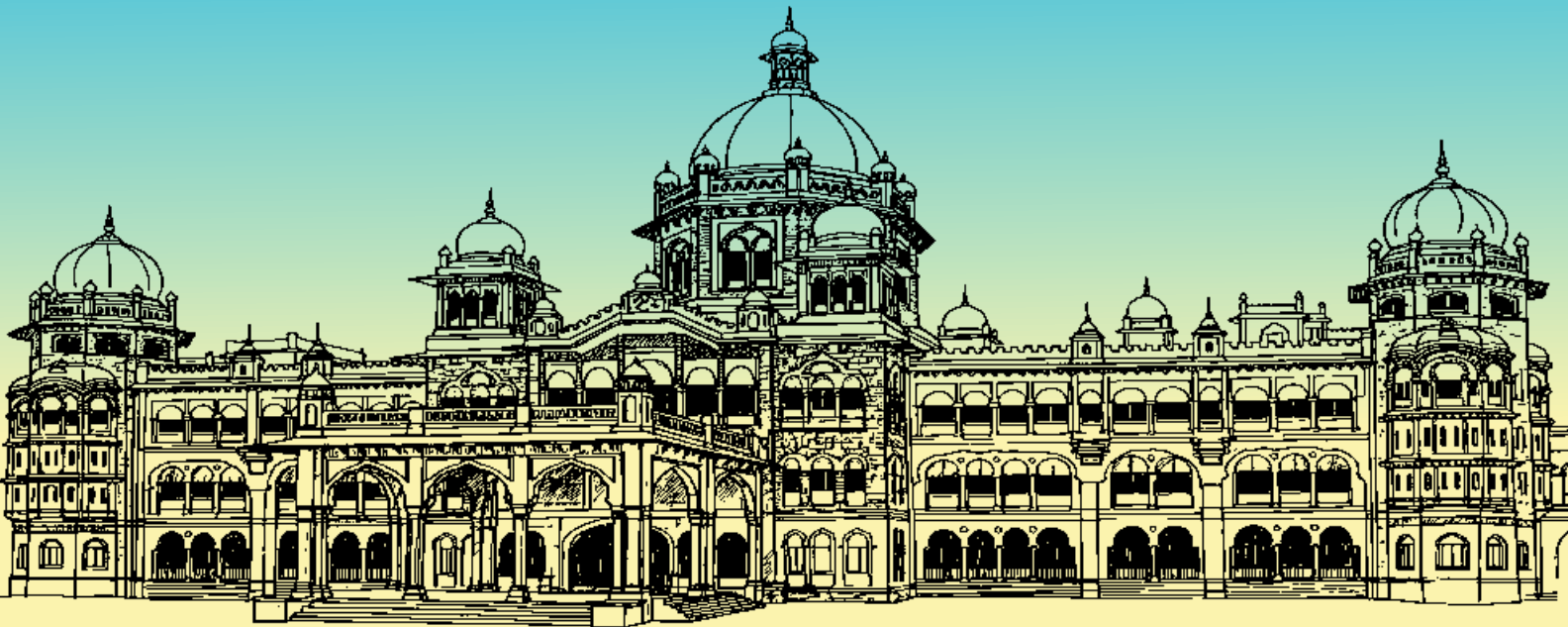

Mysuru, formerly known as Mysore, is a historic city in Karnataka celebrated as the “Cultural Capital of Karnataka” for its royal heritage, rich traditions, and architectural grandeur. The city traces its origins to the legend of Mahishasura, the demon slain by Goddess Chamundeshwari on Chamundi Hill, which gave Mysuru its name. Over the centuries, Mysuru flourished under the rule of dynasties such as the Gangas, Cholas, Hoysalas, and most prominently the Wodeyars, who established it as their capital and nurtured its growth into a cultural hub. Their legacy endures through iconic landmarks like the Mysore Palace, Chamundi Hills, and the world-renowned Dasara festival, where myth, monarchy, and modernity converge in spectacular harmony. Beyond its majestic richness, Mysuru is equally admired for its living traditions—the elegance of Mysore silk sarees, the artistry of sandalwood carvings, and the irresistible sweetness of Mysore Pak. With its blend of heritage, culture, and natural beauty, Mysuru stands out as one of India's cleanest and most charming destinations.

How to Reach the Venue

To reach B.N. Bahadur Institute of Management Sciences (BIMS) in Manasagangotri, Mysuru, locate the University of Mysore campus, one of the city's most prominent landmarks.



By Air: Mysore Airport (Mandakalli Airport), primarily used for domestic flights and is served by select major airlines, is located about 12 km from the University of Mysore. From the airport, autorickshaws, cabs, and taxis are readily available to reach the campus. The drive follows the Mysore–Nanjangud Road and then connects to Hunsur Road, where the venue is situated, making the journey convenient and accessible.



By Rail: The main railway station serving Mysuru city is Mysuru Junction (MYS), which is the city's main railway station and is well connected to Bengaluru, Chennai, Hyderabad, Kochi, and other major cities. The city's main station is about 5 km from the University of Mysore campus. From the station, autos or taxis take 15–20 minutes to the campus, where BIMS is located.



By Road: Mysuru is well connected through highways and expressways. It is primarily linked by NH 275, connecting the city to Bengaluru. Regular bus services operated by the Karnataka State Road Transport Corporation, as well as private luxury coaches, provide convenient travel between Mysuru and neighbouring cities. Within the city, autos, taxis, and local buses ensure easy access to the campus, with Basappa Memorial Hospital serving as a prominent landmark near the institute.

Tourist Attractions

Mysuru Palace (Amba Vilas Palace)



The Mysuru Palace, also known as Amba Vilas Palace, is the most iconic landmark of the city and one of the finest royal palaces in India. Built in Indo-Saracenic architectural style, the palace is adorned with ornate arches, domes, intricate wood carvings, stained glass ceilings, and expansive durbar halls. The interiors reflect royal grandeur through displays of paintings, artifacts, ceremonial weapons, and royal furniture. The palace illumination on Sunday evenings and during festivals transforms the structure into a breathtaking spectacle, attracting visitors from across the globe.

Chamundi Hill & Sri Chamundeshwari Temple

Chamundi Hill rises majestically overlooking the city of Mysuru and holds immense religious and cultural significance. The Sri Chamundeshwari Temple, dedicated to Goddess Chamundeshwari, is one of the most revered Shakti Peethas in South India. The hill provides panoramic views of the city and surrounding landscape. En route to the temple, visitors can witness the massive monolithic Nandi statue, carved out of a single rock. The location is ideal for spiritual seekers as well as nature lovers.



Jaganmohan Palace & Art Gallery



Jaganmohan Palace is a historic structure that once served as an alternate royal residence. Today, it houses an impressive art gallery showcasing traditional Mysuru paintings, royal portraits, and masterpieces by renowned artists including Raja Ravi Varma. The palace architecture itself reflects regal elegance and cultural depth, making it a must-visit destination for art enthusiasts and history lovers.

St. Philomena's Cathedral

St. Philomena's Cathedral is one of the largest churches in South India and a striking example of Neo-Gothic architecture. Inspired by Cologne Cathedral in Germany, the structure features towering twin spires, beautiful stained glass windows, and a serene prayer hall. The cathedral stands as a symbol of communal harmony and architectural excellence in Mysuru.



Brindavan Gardens & Krishna Raja Sagara (KRS) Dam



Located near the Krishna Raja Sagara Dam, Brindavan Gardens is world-famous for its symmetrical design and musical fountain shows. The gardens are beautifully landscaped with terraces, lawns, and floral arrangements. The musical fountain show in the evening, synchronized with lights and music, is a major attraction. The adjoining KRS Dam is a significant engineering marvel and a vital water source for the region.

Sri Chamarajendra Zoological Gardens (Mysuru Zoo)

Established in the year 1892, Mysuru Zoo is one of the oldest and best-maintained zoological parks in India. Known for its spacious enclosures and emphasis on animal welfare, the zoo houses a wide variety of species including big cats, elephants, giraffes, and exotic birds. It also plays an active role in conservation and breeding programs.



Karanji Lake & Nature Park



Karanji Lake is a peaceful ecological destination located within the city. It features a large walk-through aviary, butterfly park, boating facilities, and well-maintained walking paths. The lake attracts numerous migratory birds and offers a refreshing escape for visitors seeking tranquility amidst nature.

Srirangapatna - Historic Town Near Mysuru

Located a short distance from Mysuru, Srirangapatna is a historic town associated with the reign of Tipu Sultan. Key attractions include the Ranganathaswamy Temple, Tipu Sultan's Summer Palace, Gumbaz Mausoleum, and remnants of the old fort. The town is of great historical importance and provides valuable insights into South Indian history and colonial-era conflicts.
