

Frequently Asked Questions (FAQs) on Restructured CSEET

(Effective from June 2026 Session)

1. What is the effective date of the implementation of restructured CSEET?

The restructured CSEET will be applicable for candidates registering on or after 16th December 2025. The first examination under the revised structure will be held in June 2026.

2. When is the First attempt to appear for CSEET under the restructured Centre Based CSEET Examination?

The First attempt to appear for CSEET under the restructured Centre Based CSEET Examination is June 2026.

3. When is the last attempt to appear for CSEET under the present remote proctored mode?

The last attempt for CSEET in present remote proctored mode is January 2026 to be held on 10th January 2026.

4. How many times will CSEET be conducted in a year?

CSEET will be held three times a year — in the first week of February, June, and October.

5. What is the mode of restructured CSEET examination?

The restructured CSEET will be conducted in Examination Centre Based Mode at designated examination centres across different cities in India.

6. What are the timings of the examination?

The examination will be conducted in the second half of the day i.e. Afternoon session:

- For subjective papers: 2:30 PM to 5:45 PM
- For OMR-based paper: 2:30 PM to 4:45 PM

Candidates will be given 15 minutes of question paper reading time in all the papers.

7. What is the structure and pattern of the examination?

8. What is the eligibility criteria for appearing in CSEET?

- Only Indian Nationals are eligible to apply.
- A candidate who has passed or is appearing in the Senior Secondary (10+2) Examination or its equivalent is eligible to register for CSEET.

9. Who are exempted from appearing in CSEET?

The following categories are exempted and can directly register for the CS Executive Programme:

- Candidates who have passed the ICSI Foundation Examination.
- Candidates who have passed the Final Stage of CA (ICAI).
- Candidates who have passed the Final Stage of CMA (ICMAI).
- Graduates and Postgraduates in any discipline.
- Final year/semester students of Bachelor's Degree can also register directly for the Executive Programme.

10. What is the validity period of CSEET registration?

The CSEET registration is valid for 3 years from the month of registration.

11. What is the passing criteria for CSEET?

A candidate shall be declared pass in CSEET if he/she secures in one sitting, a minimum of forty percent marks in each paper and fifty percent marks in the aggregate of all papers of CSEET. There is no provision for exemption or carry forward of marks in CSEET.

12. Will a physical mark sheet be issued to CSEET Students?

No. Only E-Marksheets will be issued. Physical mark sheets will not be provided.

13. What is the validity of the CSEET result?

The CSEET Result will only be valid for a period of **One year** from the date of declaration of result and students passing the CSEET should register for CS Executive Programme within the said period.

Yes, Free online Classes will be conducted for each session for the registered students of CSEET

26. When will be the study material issued to students ?

The study material will be made available to the students at the time of registration. Study material will also be made available on the website of the Institute.

28. Is there any negative marking in OMR based papers of CSEET?

No. There will be no negative marking for wrong answers in the OMR-based papers of CSEET.

29. How many attempts are allowed under restructured CSEET Examination?

Students are allowed to appear in restructured CSEET Examination till validity of CSEET Registration..

30. Is the student required to remit Registration Fee again at the time enrollment for each examination session in case of any unsuccessful attempt?

Students are required to register for CSEET only once can appear in any examination session till the validity of registration i.e., 3 years from the month of registration.

Students are allowed to appear in restructured CSEET Examination till validity of CSEET Registration..
