India's banking system liquidity deficit jumps to over 4year high (September 20, 2023)

India's banking system liquidity deficit is at its widest in over four years ago, amid tax outflows and the lack of any major inflows, traders said on September 20, 2023. Banking system liquidity deficit jumped to 1.47 trillion rupees (\$17.67 billion) as on September 18, the highest single day shortfall since April 23, 2019, while banks have borrowed a record 1.97 trillion rupees from the central bank's Marginal Standing Facility window.

Insolvency and Bankruptcy

Amendments to Insolvency and Bankruptcy Board of India (Model Bye-Laws and Governing Board of **Insolvency Professional Agencies) Regulations, 2016** and Insolvency and Bankruptcy Board of India (Insolvency **Professionals**) **Regulations**, 2016 (September 20, 2023)

The Insolvency and Bankruptcy Board India (IBBI/ Board) notified the Insolvency and Bankruptcy Board of India (Model Bye-Laws and Governing Board of Insolvency Professional Agencies) (Amendment) Regulations. 2023 and Insolvency and Insolvency and Bankruptcy Board of India (Insolvency Professionals) (Second Amendment) Regulations, 2023 on September 18, 2023.

The amendments aim to simplify the enrolment and registration process, streamlining the exit and attendant compliance obligations in the Insolvency Profession.

Salient features and Guidelines of PM Vishwakarma Scheme (September 20, 2023)

PM Vishwakarma, a Central Sector Scheme, was launched on 17th September, 2023 by the Prime Minister to provide end-to-end support to artisans and craftspeople who work with their hands and tools. The Scheme covers artisans and craftspeople engaged in 18 trades. viz.(i) Carpenter (Suthar/Badhai); (ii) Boat Maker; (iii) Armourer; (iv) Blacksmith (Lohar); (v) Hammer and Tool Kit Maker; (vi) Locksmith; (vii) Goldsmith (Sonar); (viii) Potter (Kumhaar); (ix) Sculptor (Moortikar, stone carver), Stone breaker; (x) Cobbler (xi) Mason (Charmkar)/ Shoesmith/Footwear artisan; (Rajmistri); (xii) Basket/Mat/Broom Maker/Coir Weaver; (xiii) Doll & Toy Maker (Traditional); (xiv) Barber (Naai); (xv) Garland maker (Malakaar); (xvi) Washerman (Dhobi); (xvii) Tailor (Darzi); and (xviii) Fishing Net Maker. In addition to the above-mentioned benefits, the Scheme will onboard the beneficiaries on Udyam Assist Platform as 'entrepreneurs' in the formal MSME ecosystem.

Amendment to Legal Metrology Act, 2009 (September 20, 2023)

The Central Government has appointed 1st October, 2023 as the date on which the provisions of the Jan Vishwas (Amendment of Provisions) Act, 2023(said Act), in so far as it relates to serial number 40, and the entries relating thereto in the Schedule to the said Act, relating to the Legal Metrology Act, 2009 shall come into force.
