- (1) Any student from all over India who have completed Class 12th and not more than 25 years as on date shall be eligible to participate in the Online Quiz
- (2) Students will be required to submit the answers through Google Form.
- (3) Winners will be selected out of the correct entries (received from 10:30 AM till 2:00PM of same day).
- (4) No entry will be accepted before 10:30 am and after 2 p.m. Duration of the Competition will be 20 minutes during which a student is required to attempt 25 questions.
- (5) Each correct reply carries 1 mark. There is no negative marking for incorrect answers.
- (6) A student will be allowed to appear only once in a competition.
- (7) The documents supporting the eligibility of the candidate can be verified any time before or after the test.
- (8) The Online Quiz Competition shall be in MCQ Pattern in Anywhere mode. Students can participate in the Quiz through Mobiles, Tablets, Laptops and Desktops which have internet connectivity from their respective locations.
