Academic Guidance

An Overview of E-Banking in India*

Introduction

Internet Banking or E-Banking refers to a system that allowing individual customers to perform various banking activities from different sites like their home, office and other locations via internet based secured networks. Through Internet or online banking traditional banks have enabled customers to perform all routine transactions, such as account transfers, balance inquiries, bill payments and stop-payment requests and some even offer online loan and credit card applications.

Banks have traditionally been in the forefront of harnessing technology to improve their products, services and efficiency. They have, over a long time, been using electronic and telecommunication networks for delivering a wide range of value added products and services. The delivery channels include direct dial – up connections, private networks, public networks etc. and the devices include telephone, Personal Computers including the Automated Teller Machines, etc.

With the popularity of PCs, Laptops, Mobile phones etc. easy access to Internet and World Wide Web (WWW), Internet is increasingly used by banks as a channel for receiving instructions and delivering their products and services to their customers. This form of banking is generally referred to as Internet Banking, although the range of products and services offered by different banks vary widely both in their content and sophistication.

Broadly, the levels of banking services offered through INTERNET can be categorized in to three types: (i) The Basic Level Service is the banks' websites which disseminate information on different products and services offered to customers and members of public in general. It may receive and reply to customers' queries through e-mail, (ii) In the next level are Simple Transactional Websites which allow customers to submit their instructions, applications for different services, queries on their account balances, etc., but do not permit any fund-based transactions on their accounts, (iii) The third level of Internet banking services are offered by Fully Transactional Websites which allow the customers to operate on their accounts for transfer of funds, payment of different bills, subscribing to other products of the bank and to transact purchase and sale of securities, etc.

The above forms of Internet banking services are offered by traditional banks, as an additional method of serving the customer or by new banks, who deliver banking services primarily through Internet or other electronic delivery channels as the value added services. Some of these banks are known as 'virtual' banks or 'Internet-only' banks and may not have any physical presence in a country despite offering different banking services.

Spreading of Wings

In India innovation in banking sector commenced since 1991 with introduction of liberalization and globalization processes as result of it E- Banking came into progress. This Information Technology revamped the entire banking sector. E-banking drastically and rapidly altered the way of client banking, banks started providing different services related to cash deposits, cash withdrawals that to through electronic means. Due to this I.T revolution, the number of electronic transactions are increasing day by day and world has emerged as a cyber world where each and everyone is connected through internet. E- Banking made the mobility of foreign funds and investment possible which turned world into global market and this market is growing so fast that it has almost abolished the effect of national boundaries. It is not wrong to say that this I.T innovation in baking sector in form of E-banking has introduced new business paradigm in country like in India.

In past three decades the operational efficiency of Indian banks has increased to several folds, now the time taken by the banks in performing different transaction has been reduced, with this advancement competition among banks has also increased. Every bank is trying to use as much latest technological innovations in order to facilitate its customers. One of the key features in this regard is innovation banking or e- banking, which a lot of banks are currently providing in India.

Union Budget 2022 and E-Banking

The Finance minister announced in her Budget 2022 speech that all 1.5 lakh branches of Post Office will be linked to the core banking system by the end of 2022. This will allow all post office saving account holders to access internet banking and conduct online payment and money transfer. While a large number of post office branches were already there on the core banking system however all post offices are not on the core banking system as yet. Therefore, transfer of funds via internet banking from a core-banking enabled post office to one which is not part of the core banking system is not possible. Besides the internal online transfers, post office account holders will also be able to transfer funds to savings account with any other bank via internet banking.

Further, the move to connect 1.5 lakh post offices in India to the core banking system is also a welcome move. This shall enhance the overall banking experience with easy access to post offices through ATMs, mobile, and net banking. This will further support the Government's plans to encourage digital banking in the country where most people, particularly in rural areas, make use of the services of post offices to deposit their money.

Conclusion

Electronic banking offers a lot of benefits to individual customers, businesses, and banks. However, one should not ignore the risks associated with e-banking. The following are the risks associated with e-banking:

- 1. **Operational Risks** Operation risk or transactional risk is the most common type of risk of ebanking. It includes:
 - Incorrect transaction processing
 - Compromises in the integrity of data, data privacy, and confidentiality
 - Unauthorized access to the bank's systems
 - Non-enforceability of contracts, etc.

Apart from technological errors, human factors like negligence (customers or employees), employee frauds, hackers, etc. are a potential source of operational risk of e-banking.

- 2. **Security Risk** When we talk about banking transactions, security of the transaction is of paramount importance. All customers want their transactions to be confidential. However, since all information is online, there is always a chance that someone might retrieve the information and misuse it. The security risk of e-banking also arises from hacking threats and unauthorized access to the bank's systems.
- 3. **Reputational Risk** For any business, its reputation is of critical importance. When it comes to electronic banking, if a bank fails to perform critical functions or not work according to the expectations of its customers, then it faces a risk of loss of reputation. This eventually leads to a loss of funding or customers.

Some reasons for this risk are a system or product not functioning as expected, significant deficiencies in the system, security breaches (external or internal), misinforming customers about the processes and policies of using e-banking, certain communication issues that hinder the customer from accessing his / her account, etc.

- 4. **Legal Risk** Whenever there is a violation of laws, regulations, or prescribed practices, or when the legal rights and obligations of any of the parties to a transaction are not established, then there is a legal risk involved. E-Banking is relatively new to the industry and there is a lot of uncertainty and ambiguity about certain laws and rules. This increases the legal risk.
- 5. **Money Laundering Risk** All transactions through the e-banking channel are done remotely. Therefore, it is difficult for banks to use traditional methods to detect and prevent criminal activities. While there are certain money laundering rules in place, for electronic payments, their feasibility is questionable. Therefore, banks carry the risk of money laundering.
- 6. **Cross-border Risks** The core idea of electronic banking is to extend the geographical reach of both banks as well as customers. This means that the expansion can go beyond national borders. This leads to several cross-border risks:
 - a) *Legal and Regulatory risks* There is a possibility about uncertainties regarding the legal requirements in certain countries and jurisdiction ambiguities of different national authorities.
 - b) *Operational risk* If the bank uses a service provider located in a different country, then it is difficult to monitor it causing operational risk.
 - c) *Credit risk* Cross-border transactions can increase credit risk. This is because it is difficult to appraise an application for a loan from a customer in a different country.
- 7. **Strategic Risk** This risk is associated with issues pertaining to:
 - The development of a business plan
 - Having sufficient resources available to support the business plan
 - In the case of outsourced activities, the credibility of the vendor
 - For employees, any change in the work environment
 - Level of technology used in comparison with the available technology, etc.
- 8. **Other Risks** The other risks of e-banking are the same as those of traditional banking like credit risk, liquidity risk, interest rate risk, market risk, etc. However, in e-banking, these risks are magnified due to the use of electronic channels and the absence of geographical boundaries.

Thus, to provide impetus to the growth of e-banking in India, more measures apart from those in existence may be undertaken. If the aforesaid risks are addressed properly then it will inculcate confidence among the customers of the banks.

REGISTRATION

1. VALIDITY OF CS FOUNDATION PROGRAMME ADMISSION

Foundation Programme Registration is normally valid for a period of three years from the date of registration or till student passes the CS Foundation Programme examination of the Institute whichever is earlier subject to the Regulation of the Institute, as in force from time to time. Further, New Admissions to the Foundation Programme of CS Course stands discontinued from 3rd February 2020.

(Note : Existing Foundation Programme Students shall be allowed to appear in the Foundation Programme Examinations till expiry of the validity of their registrations. Such students, after passing the Foundation Programme Examinations, may register for Executive Programme as per existing process.)

2. **REGISTRATION FOR CS EXECUTIVE PROGRAMME**

In order to become eligible for registration as a student of Executive Programme, an applicant, who is an Indian National, shall apply in the appropriate form, along with the student registration fee, annual subscription, if applicable, education fee and such other fees, as may be determined by the Council and shall also produce proof to the satisfaction of the Council that he,-

- a. has passed Senior Secondary Examination (10+2 system) conducted by an examining body constituted by law in India or an examination recognized by the Central Government or State Government or equivalent thereto for the purposes of admission to Bachelor's degree course and has complied with such requirements as may be determined by the Council; and
- b. has passed Company Secretary Executive Entrance Test (CSEET) conducted by the Institute in such manner, mode and eligibility as may be determined by the Council or any other test or examination recognised or equivalent thereto or exempted therefrom by the Council:

Provided that from the date of the introduction of the Company Secretary Executive Entrance Test under these regulations, all the students of Foundation Programme having valid registrations immediately before the date of introduction of the Company Secretary Executive Entrance Test, may be given such relaxation for number of attempts in the Foundation Programme Examination or allowed to appear in the Company Secretary Executive Entrance Test as may be determined by the Council:

Provided further that the number of attempt or relaxation in the Foundation Programme Examination shall in no case be beyond the date of expiry of his registration.

CS Executive Entrance Test (CSEET) is being introduced which will be a mandatory qualifying test for all categories of students for registration to Executive Programme except a few exempted categories.

The following categories of students shall be exempted from qualifying CSEET and can seek registration directly to Executive Programme :

- a. CS Foundation Programme passed students Exemption Fee Nil
- b. ICAI (The Institute of Chartered Accountants of India) Final Course passed students - Exemption Fee : Rs. 5000/-

- c. ICMAI (The Institute of Cost Accountants of India) Final Course passed students - Exemption Fee: Rs. 5000/
- d. Graduates with 50% marks and Post Graduates Exemption Fee: Rs. 5000/



2. STUDENT IDENTITY CARD

Identity Card can be downloaded after logging into the Student Portal at *www.icsi.edu.* After downloading the Identity card, students are compulsorily required to get it attested by any of the following authorities with his/her seal carrying name, professional membership No., designation and complete official address:

- 1. Member of the Institute, with ACS/FCS No.
- 2. Gazetted Officer of the Central or State Government.
- 3. Manager of a Nationalized Bank.
- 4. Principal of a recognized School/College.
- 5. Officer of ICSI.

Unattested Identity Cards are not valid and the students are advised to carry duly attested Identity Card for various services during their visits to the offices of the Institute, Examination Centres, etc.

3. DEDUCTION OF 30% OF THE TOTAL FEE REMITTED BY THE APPLICANT IN RESPECT OF REGISTRATIONS LYING PENDING FOR MORE THAN A YEAR

The Institute has decided to reject the applications of such students who do not submit the documents within one year after their registration in Foundation and Executive programme by deducting 30% of the fee remitted by them towards administrative charges after expiry of one year. Therefore it is advised that all such students may complete all formalities to approve the registration in the stipulated time period failing which their registration applications would be rejected.

1. Chartered Secretary Journal

The "Chartered Secretary" Journal is published by the ICSI, with a view to ensure continuous up-gradation of the knowledge of the Members. The Journal is equally important for the students of the Institute. Students who are interested to purchase the journal can subscribe for the same by remitting the nominal subscription fees of Rs. 500/- per annum. Students can either subscribe for the Journal at the time of registration in each stage of CS Course or separately through our Chartered Secretary division.

Guidelines for Concession in Fee for Registration to CS Course to the Widows and Wards of Martyrs, Permanent Disability cases, Serving / Retired Personnel of Indian Army, Indian Air Force, Indian Navy and all para military forces

The sacrifice of the personnel of Indian Armed forces and para military forces for maintaining the security and sovereignty of the country is commendable.

In a humble endeavor of the Institute in recognizing the contribution of the serving and retired personnel and as a goodwill gesture to the families of martyrs, the Institute has decided to grant the following concessions for registration to the CS Course :

- i. 100% concession in full Fee payable at the time of Registration to various Stages of CS Course and Examination Fee to the wards and widows of martyrs of Indian Army, Indian Air Force, Indian Navy and all para military forces
- 100% concession in full Fee payable at the time of Registration to various ii. Stages of CS Course and Examination Fee to the personnel of Indian Army, Indian Air Force, Indian Navy and all para military forces with permanent disability as a result of participating in act of war and other missions.
- 50% concession in full Fee payable at the time of Registration to various Stages iii. of CS Course and Examination Fee to all In Service/Retired personnel of Indian Army, Indian Air Force, Indian Navy and all para military forces.
- All other fee payable by the aforesaid category of students shall be as per the iv. rates applicable to the general category students.

These guidelines shall be applicable effective from 1st April, 2019.






