**ORDER**

1. The Appellant has filed first appeal on 14.07.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No.: Registration Number: ICSOI/R/E/22/05105 dated 06.07.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 11.06.2022 has requested to provide following information under RTI act:  
1) What is procedure for selection of an examination center? if any checklist/ criteria is there same to be provided. 2) Evaluation / inspection Report of committee selecting the examination center SUVIDYA ENGLISH HIGH SCHOOL SUSHILA COMPLEX, OPP. MUKUND HOPITAL NEAR AIRPORT ROAD METRO STATION, ANDHERI-KURLA ROAD, MAROL PIPELINE ANDHERI (EAST) MUMBAI - 400059. 3) Whether ICSI has received any complaint against examination center SUVIDYA ENGLISH HIGH SCHOOL, if yes, then whether any action has been taken by ICSI. 4) If any action is taken, share the details of action taken.
3. The Appellant has requested in the instant appeals that 'No information has been provided taking shelter of highly misused clause RTI act. Not accepted from an Institution claiming to be body of Governance professional'.
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the information sought by Applicant (Appellant hereinabove) was provided in accordance with the provisions of the RTI Act. Further, the information sought by the Appellant vide RTI Application No. ICSOI/R/E/22/05105 dated 11.06.2022 has already been provided vide RTI reply dated 06.07.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

6. This Office concurs with the submission of the Respondent.

The extracts of the reply are given as under-

- (1) Reply to Query no. 1 - The information sought is exempt from disclosure under section 8(1)(d) of the Right to Information Act, 2005.
- (2) Reply to Query no. 2 - The information sought is exempt from disclosure under sections 8(1)(d), 8(1)(e) and 8(1)(j) of the Right to Information Act, 2005.
- (3) Reply to Query no. 3 - Yes. One complaint purported by the applicant and the necessary action has been taken.
- (4) Reply to Query no. 4 - The reply has been sent separately to the applicant at email manojuuu@yahoo.co.in vide email dated 30th June 2022.

The appeal is accordingly disposed of.
