ORDER

- i. The Appellant has filed first appeal on 21.11.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/12466 dated 21.11.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- ii. The Appellant vide her application dated 27.10.2022 has requested to provide the answer sheet of the CS Executive examination, session June 2022 for both the modules. Group (1) JIGL, SBEC, TAX LAW, CLAW, GROUP (2) SLAW, EBCL, CMA, FMSM.
- iii. The Appellant has informed in the instant appeals that "Details not provided".
- iv. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the RTI Applicant (Appellant hereinafter) has filed three Appeals vide Appeal Nos. ICSOI/A/E/22/00097, ICSOI/A/E/22/00098 and ICSOI/A/E/22/00099 dated 21.11.2022 as above against her RTI Application vide Application No. ICSOI/R/E/22/12466 dated 27.10.2022 seeking information.

2. It is further submitted that we have provided the requisite information on 21.11.2022 in which a web-link, Username and Password has been provided to the Appellant to access her answer copies. Further, the access of the requisite information has been acknowledged by the Appellant vide email dated 21.11.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

- v. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- vi. The Office concurs with the submission of the Respondent. It is observed that Appellant has acknowledged the receipt of information sought vide email dated 21.11.2022.

The appeal is accordingly disposed of.
