ORDER

- The Appellant has filed first appeal on 06.01.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with response Ref. No. RTI 2005/5429(23) dated 05.01.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- The Appellant vide his application dated 07.12.2022 has requested to provide various information related to employees & copy of proceeding, office noting and other documents of the Applicant through RTI.
- 3. The Appellant has requested in the instant appeals that "The requested information has not been provided saying the queries are same as in my earlier RTI application dated 16-03-2021. has been cited provision of RTIact to deny the Earlier the hon'ble CIC had held that the queries in RTI application cannot be denied, however the PIO has not provided the information sought and malafidely violated the order of Hon'ble hinderance providing CIC bv creating active in inspection. In view of above the appeal may be allowed and requisite information may be provided at the earliest."
- 4. The reply of the Respondent against the instant appeal is as under:-

With respect to the RTI Application of the Appellant dated 07.12.2022, the queries are the same as mentioned in earlier RTI Application of the Appellant dated 16.03.2021, which have been disposed off including Appeal to First Appellate Authority and subsequent Appeal to Learned Central Information Commission.

In view of the foregoing, we reiterate our earlier reply and therefore, the appeal deserves to be dismissed."

- 4. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 5. This Office concurs with the submission of the Respondent.

The appeal is accordingly disposed of.
