**ORDER**

1. The Appellant has filed first appeal on 09.09.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/06820 dated 09.09.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 26.08.2022 has requested to provide certified copies of answer sheet under RTI Act 2005 for CS Executive Examination: year 2022.
3. The Appellant has informed in the instant appeals that "Refused access to Information Requested" & requested to provide Certified Copies of Answer Sheets under the Right to Information Act, 2005.
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information/documents as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/22/06820 dated 26.08.2022, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 08.09.2022 in which a web-link, Username and Password have been provided to the RTI Appellant to download and view the requisite Answer Books.

Further, the Appellant updated his email id registered with the Institute and upon confirmation, the information was once again provided to the applicant on the newly updated email on 28.09.2022. Furthermore, the Appellant acknowledged the receipt of information on his updated email id vide email dated 28.09.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. The Office concurs with the submission of the Respondent. Appellant has acknowledged the receipt of information vide email dated 28.09.2022.

The appeal is accordingly disposed of.
