ORDER

- 1. The Appellant has filed first appeal on 05.04.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. RTI 03221 dated 20.03.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 07.03.2022 has requested to provide the certified copy of CS. Executive Old Syllabus for December 2021.
- 3. The Appellant has requested in the instant appeals that "The request has been disposed off by the office. As no reason for the disposal was specified by the authority. Please provide the Requested information as soon as possible."
- 4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the information sought has been provided to the Applicant (Appellant hereinabove) at her email id registered with the Institute of Company Secretaries of India vide Email dated 17.03.2022 in which a web-link, Username and Password have been provided to the Appellant to download and view the answer books.

Further, the said information has been once again provided to the Appellant vide email dated 08.04.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine".

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. This Office concurs with the submission of the Respondent. Further, in case, the user name & password as emailed has not been received, the appellant may approach the respondent within 03 days of issue of this order. It is further directed to the respondent that if approached again the respondent to share the document by email within 7 days of being approached.

The appeal is accordingly disposed of.
