**ORDER**

1. The Appellant has filed first appeal on 09.04.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No.: Registration Number: ICSIO/R/E/22/01142 dated 14.03.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 26.02.2022 has requested to supply certified copies of professional programme appeared in December 2021 examination.
3. The Appellant has requested in the instant that "I got your mail in the spam box, because of this I could not see the mail in the specific time, I came to know about the mail yesterday but by then the time was over  
Couldn't see my certified copy in such a reason, kindly please resend my copies".
4. The reply of the Respondent against the instant appeal is as under: -  
  
"It is submitted that the information sought has been provided to the Applicant(Appellant hereinabove) at his email id registered with the Institute of Company Secretaries of India vide Email dated 10.03.2022 in which a web-link, Username and Password have been provided to the Appellant to download and view the answer books.

Further, Upon receiving the request from the Appellant in his Appeal the viewing time of the information was extended till 30th April 2022 and thus the Appellant was able to access the requisite information. Furthermore, the same was confirmed by the Appellant vide email dated 14.04.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine”.

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. This Office concurs with the submission of the Respondent. It is found that Appellant has confirmed vide email dated 14.04.2022 that “Thank you for resolving technical errors which I have facing in open my certified copies’.

The appeal is accordingly disposed of.
