ORDER

1. The Appellant has filed first appeal on 17.10.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/12335 dated 17.10.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide her application dated 12.10.2022 has requested to provide certified copies of June 2022 all examinations of ICSI.
3. The Appellant has informed in the instant appeals that "Refused access to Information Requested."
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the Applicant (Appellant hereinafter) did not provide the details inter alia including Roll Number and/or Registration Number necessary for providing copy of Answer Books in her RTI Application no. ICSOI/R/E/22/12335 dated 12.10.2022 and the RTI Application was disposed of accordingly. Now, the Appellant provided her Registration Number in the above mentioned Appeal and accordingly the information sought has been provided to the Appellant at her email id registered with the ICSI vide email dated 19.10.2022.

Further, the Appellant acknowledged the receipt of information sought vide email dated 20.10.2022.

The contents as above made in the RTI reply stands as it is and are

candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. The Office concurs with the submission of the Respondent. It is observed that Appellant has acknowledged the receipt of information sought vide email dated 20.10.2022.

The appeal is accordingly disposed of.
