**ORDER**

1. The Appellant has filed first appeal on 17.10.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/12305 dated 17.10.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide her application dated 10.10.2022 has requested to furnish the examination copies of June 2022 attempt.
3. The Appellant has requested in the instant appeals that “ please furnish the requested copies of the examination. Hoping for a positive response.”
4. The reply of the Respondent against the instant appeal is as under: -

“It is submitted that we have provided the requisite information/documents as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/22/12221 dated 04.10.2022, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 10.10.2022 in which a web-link, Username and Password have been provided to the RTI Appellant to download and view the requisite Answer Books.

Further, the Appellant filed another RTI Application having Reg. No. ICSOI/R/E/22/12305 dated 10.10.2022 seeking the same information, and the same has been disposed of accordingly for being the duplicate of the previous one.

Furthermore, the Appellant acknowledged the receipt of information sought vide email dated 19.10.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. The Office concurs with the submission of the Respondent. It is observed that Appellant has acknowledged the receipt of information sought vide email dated 19.10.2022.

The appeal is accordingly disposed of.
