ORDER

- 1. The Appellant has filed first appeal on 16.04.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/01366 dated 15.03.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 27.02.2022 has requested to provide copy of answer sheet.
- 3. The Appellant has requested in the instant appeals that "I hereby request the recopy of ICSI answer sheet."
- 4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the information sought has been provided to the Applicant (Appellant hereinabove) at her email id registered with the Institute of Company Secretaries of India vide Email dated 14.03.2022 in which a web-link, Username and Password have been provided to the Appellant to download and view the answer books.

Further, the information sought was again provided to the Appellant on her request on 19.04.2022 and the receipt of the information sought was confirmed by the Appellant vide email dated 20.04.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. This Office concurs with the submission of the Respondent. It is found that Appellant has confirmed the receipt of answer sheet vide email dated 20.04.2022.

The appeal is accordingly disposed of.
