ORDER

- 1. The Appellant has filed first appeal on 15.12.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with response Ref. No. RTI 2005/5298(22) dated 22.04.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 13.11.2022 has requested to provide the various information of candidates who have called for the interview i.e. marks, name, qualification, Caste category, interview comments, Order/notification etc.
- 3. The Appellant has informed in the instant appeals that "Refused access to Information Requested". Further, Appellant has requested to provide the requisite information.
- 4. The reply of the Respondent against the instant appeal is as under: -

"Written submission to query numbers 1 to 3:- Since the information pertaining to marks obtained by the candidates is personal information the disclosure of which has no relationship to any public activity or interest and hence exempted under section 8(1) (j) of the RTI Act, 2005.

Written submission to query number 4:- The detailed marks obtained by the Appellant has already been provided through RTI Reply.

Written submission to query number 5:- As per record, no such information is available.

We reiterate our earlier reply and therefore, the appeal deserves to be dismissed".

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

6. This Office concurs with the submission of the Respondent. It has been noticed by this Office that the detailed marks obtained by the Appellant has already been provided by the Respondent. Since the information pertaining to marks obtained by the candidates is personal information the disclosure of which has no relationship to any public activity or interest and hence exempted under section 8(1) (j) of the RTI Act, 2005.

The appeal is accordingly disposed of.
