- 1. The Appellant has filed first appeal on 22.03.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No.: Registration Number: ICSOI/R/E/22/02859 dated 22.03.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 04.03.2022 has requested to provide Certified Copies of Answer Sheets under the Right to Information Act 2005.
- 3. The Appellant has requested in the instant appeals "to provide certified copies of my papers for the December examination".
- 4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information/documents at the registered Email ID of the Appellant with the Institute of Company Secretaries of India vide Email dated 21.03.2022 in which a web-link, Username and Password have been provided to the RTI applicant (appellant hereinabove) to download and view the answer books.

The contents as above made in the RTI reply stands as it is and are candid."

Therefore, the appeal deserves to be dismissed in-limine."

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. The submissions of the Respondent is taken on record. It is directed that in case, the user name & password as emailed, has not been received, the appellant may approach the respondent within 03 days of issue of this order. It is further directed to the respondent that if approached again the respondent to share the document by email within 7 days of being approached.

The appeal is accordingly disposed of.
