## ORDER

- 1. The Appellant has filed first appeal on 15.09.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/08091 dated 15.09.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 29.08.2022 has requested to provide answer book of the Board Examination of CS Executive, Session June 2022.
- 3. The Appellant has informed in the instant appeals that "Details not provided".
- 4. The reply of the Respondent against the instant appeal is as under: -

provided is submitted that we have the requisite information/documents as sought by the Applicant (Appellant Application ICSOI/R/E/22/08091 hereinafter) in his RTIdated 29.08.2022, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 13.09.2022 in which a web-link, Username and Password have been provided to the RTI Appellant to download and view the requisite Answer Books. Further, the Appellant acknowledged the receipt of information vide email dated 30.09.2022."

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. The Office concurs with the submission of the Respondent. It has been observed that information was provided to the Appellant vide email dated 13.09.2022. Further, Appellant vide email dated 30.09.2022 has acknowledged the receipt of information.
