ORDER

- 1. The Appellant has filed first appeal on 20.04.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No.: Registration Number: ICSOI/R/E/22/04793 dated 13.04.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 09.04.2022 has requested to provide the answer book of Professional Programme Examination (New Syllabus for December 2021 under the RTI Act.
- 3. The Appellant has requested in the instant appeals that "I have provided all the information correctly, still I have not received copies of my exam paper. Please provide me all the necessary copies mentioned in the supported document."
- 4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information/documents at the email id of the Applicant (Appellant hereinabove) registered with the Institute of Company Secretaries of India vide email dated 13.04.2022 in which a web-link, Username and Password have been provided to the RTI Appellant to download and view the answer books. Further, the said information was once again provided to the Appellant vide email dated 22.04.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine".

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. This Office concurs with the submission of the Respondent. Further, in case, the user name & password as emailed has not been received, the appellant may approach the respondent within 03 days of issue of this order. It is further directed to the respondent that if approached again the respondent to share the document by email within 07 days of being approached.

The appeal is accordingly disposed of.
