**ORDER**

1. The Appellant has filed first appeal on 18.05.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No.: Registration Number: ICSOI/R/E/22/04986 dated 04.05.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his RTI application dated 28.04.2022 has requested to provide answer sheet copies of examination which are held in December 2021 session.
3. The Appellant has requested in the instant appeal that "I m a student of Institute of Company Secretaries of India I want to check my answer sheets of exams which are held in Dec. 2021 session. I file appeal 2 times before appear here but I didn't, get the information. I request you please provide me information and kindly send me copies".
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the RTI Application No. ICSOI/R/E/22/04986 ; dated 28.04.2022 is a repeat RTI Application seeking the same information vide Applicant's RTI Application No. ICSOI/R/E/22/00476 ; dated 25.02.2022 and the requisite information in response thereto has been provided at the Email id of the Applicant (Appellant hereinabove) registered with the Institute of Company Secretaries of India vide Email dated 09.03.2022 in which a web-link, Username and Password have been provided to the Appellant to download and view the answer

books.

Furthermore, the requisite information was once again provided on 06.06.2022 at the registered email id of the Appellant.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. This Office concurs with the submission of the Respondent. Please refer email dated 06.06.2022 in which a web-link, Username and Password have been provided to the Appellant from CPIOEXAM to download and view the answer books till 15.06.2022.

The appeal is accordingly disposed of.
