## **ORDER**

- 1. The Appellant has filed first appeal on 22.02.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with response Ref. No. RTI 2005/5276(22) dated 22.02.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 18.02.2022 has requested to provide the information under the RTI Act, 2005.
- 3. The Appellant has requested in the instant appeals that "Details not provided."
- 4. The reply of the Respondent against the instant appeal is as under: -

"Our earlier reply is reiterated as it has already informed to the applicant (appellant herein) that "the regular bulk dispatch is done through bulk mailing services of India Post which one lac approx., there are chances of non-delivery/loss in transit in some cases. On receipt of any such complaint of non-receipt, we are sending alternate copy by speed post. There is no tracking mechanism when dispatch is done through bulk mailing service and Indian postal system never claims for 100% delivery and there is always 2-3% case of non-receipt of Journal/ Magazine."

However, it is to inform that as per the query raised by Mr. Vaibhav Mittal regarding the non-receipt of nine issues of Chartered Secretary i.e. from June 2021 to February 2022, the Printing Cell of the ICSI has been sent the same through Registered Parcel on March 08, 2022. The Tracking no. of the same is CU344890025IN. The packet will reach to the student in 4-5 days' time."

The contents as above made in the RTI reply stands as it is and are candid.

And in view of foregoing, the appeal deserves to be dismissed in-limine."

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. This Office concurs with the submission of the Respondent.

The appeal is accordingly disposed of.
