ORDER

1. The Appellant has filed first appeal on 08.10.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/12175 dated 07.10.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 01.10.2022 had applied to view the answer paper.
3. The Appellant has informed in the instant appeals that "Details not provided".
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the Applicant (Appellant hereinafter) did not provide the details inter alia including Roll Number and/or Registration Number necessary for providing copy of Answer Books in his RTI Application no. ICSOI/R/E/22/12175 dated 01.10.2022 and the same has been disposed of accordingly. Now, the Appellant provided the copy of his admit card of the examination in his above mentioned Appeal and accordingly the information sought has been provided to the Appellant at his email id registered with the ICSI vide email dated 19.10.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. The Office concurs with the submission of the Respondent. Respondent has provided the information to the Appellant at his email id registered with the ICSI vide email dated 19.10.2022 wherein it is mentioned that the information sought by the Appellant will remain hosted at the above link till **09-Nov-2022**.

The appeal is accordingly disposed of.
