ORDER

1. The Appellant has filed first appeal on 26.08.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. Registration Number: ICSOI/R/E/22/02098 dated 16.03.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 01.03.2022 has requested to provide certified copies of the Papers for the session Dec 2021 : JIGL : 421 COMPANY LAW : 422 SBEC : 423 TAX LAWS : 424
3. The Appellant has informed in the instant appeals that "Details not provided".
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the RTI Applicant (Appellant hereinafter) has filed the appeal on 26.08.2022 for his RTI Application No. ICSOI/R/E/22/02098 dated 01.03.2022 beyond the time limit as specified under Section 19(1) of the Right to Information Act, 2005.

2. It is further submitted that the requisite information as sought under above mentioned RTI Application ICSOI/R/E/22/02098 was supplied to the Appellant vide email dated 16.03.2022. Further, the Answer Books of CS Examination December 2021 have been disposed of as per Record Retention Schedule of the Institute and cannot be provided once again now.

3. It is also submitted that the Appellant has not mentioned any grievance against information supplied to him vide email dated 16.03.2022 in response to his RTI Application no. ICSOI/R/E/22/02098. Instead, the Appellant has sought information for which no RTI Application has been filed by him.

Therefore, the appeal deserves to be dismissed in-limine."

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. This Office concurs with the submission of the Respondent. As per Record Retention Schedule of the Institute, Answer Books of CS Examination December 2021 have been disposed of hence cannot be provided again. Further, it has been noticed that Appellant has sought information for the year June 2022 session examination for which no RTI Application has been filed.

The appeal is accordingly disposed of.
