ORDER

1. The Appellant has filed first appeal on 29.05.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with response Ref. No. RTI 2005/5310/(22) dated 28.05.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his RTI application dated 30.04.2022 has requested to provide the various information regarding application of CS Executive Module I, II & Both and CS Professional all Module. Name of all firms, companies, all other body , etc. which provides technical/software services to ICSI. Highest Educational Qualification and amount of Gross Salary in INR of the Vice President of ICSI.
3. The Appellant has requested in the instant appeal that "For Question 8 there was a typing error of CA. Actually it is CS so the question is for CS professional exam. For Question 11 the PIO has tried to evade the question. Has not provided satisfactory response. For Question 12 , 13 and 14 no satisfactory response is provided. The First Appellate Officer is requested to provide satisfactory response."
4. The reply of the Respondent against the instant appeal is as under: -

"Regarding reply to the query number 8:-

The submission is as follows:- "We reiterate our reply given to the applicant."

It is pertinent to mention that the appellant cannot change the query in Appellate Stage. However he is at liberty to make separate RTI Application.

Regarding reply to the query numbers 11 and 14:-

We reiterate our earlier reply that the appellant may refer Company Secretaries Act, 1980.

Regarding reply to the query numbers 12 and 13:-

It is to inform that the public authority under the RTI Act, 2005 is not to create or collate information; or to interpret information as per the choice of the information seeker. Therefore, reply(ies) to the query(ies) cannot be created and designed in the manner and wish of the appellant.

Please refer order issued on 09.08.2011 in the Civil Appeal No. 6454 of 2011 [Arising out of SLP [C] No. 7526/2009] in the matter of Central Board of Secondary Education & Anr. Vs. Aditya Bandopadhyay & Ors.

In view of the forgoing, we reiterate the reply.

Therefore, the contents made in the RTI reply stands as it is and the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record
6. This Office concurs with the submission of the Respondent.

The appeal is accordingly disposed of.
