**ORDER**

1. The Appellant has filed first appeal on 09.09.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. Registration Number: ICSOI/R/E/22/05982 dated 06.09.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide her RTI application dated 25.08.2022 has requested to provide certified copies of Answer sheets for CS Executive June 2022 session examination under the RTI Act, 2005.
3. The Appellant has informed in the instant appeals that "My appeal for asking my certified copies of June 2022 CS EXECUTIVE Exams has been disposed off without any reason, I really want to see the certified copies of my CS Exam, please help".
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information/documents on 02.09.2022 in which a web-link, Username and Password has been provided to the RTI Applicant (Appellant hereinafter) to download and view the answer copies.

2. It is also submitted that the Appellant subsequently filed another RTI ICSOI/R/E/22/11286 dated 14.09.2022 seeking copy of Answer Books.

3. Further, in response to RTI Application No. ICSOI/R/E/22/11286 dated 14.09.2022 requisite information was provided to the Appellant vide email dated 22.09.2022 and once again on 27.09.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. This Office concurs with the submission of the Respondent. Response of RTI application ICSOI/R/E/22/05982 dated 25.08.2022 has been provided by the Respondent through email on 02.09.2022. Further, Response of RTI Application ICSOI/R/E/22/11286 dated 14.09.2022 has been provided by the Respondent on 22.09.2022 & again on 27.09.2022 wherein it is mentioned that “The information sought by you will remain hosted at the above link till 13.10.2022”.

The appeal is accordingly disposed of.
