## ORDER

- The Appellant has filed first appeal on 11.10.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/05534 dated 06.09.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 25.08.2022 has requested to provide certified copies of answer sheets of CS Executive, session June 2022 Examination under the Right to Information Act 2005.
- 3. The Appellant has informed in the instant appeals that "No Response Within the Time Limit"& requested to provide Certified Copies of Answer Sheets under the Right to Information Act 2005.
- 4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the RTI Applicant (Appellant hereinafter) has filed the appeal on 11.10.2022 for his RTI Application No. ICSOI/R/E/22/05534 dated 25.08.2022 beyond the time limits as specified under Section 19(1) of the Right to information Act, 2005.

"It is further submitted that we have provided the requisite information/documents as sought by the Appellant in her RTI Application ICSOI/R/E/22/05534 dated 25.08.2022, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 02.09.2022 and once again on 12.10.2022 in which a web-link, Username and Password have been provided to the RTI Appellant to download and view the requisite Answer Books.

Furthermore, the Appellant acknowledged the receipt of information sought vide email dated 12.10.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. The Office concurs with the submission of the Respondent. It has been observed that information was provided to the Appellant vide email dated 02.09.2022 & 12.10.2022. Further, Appellant acknowledged the receipt of information sought vide email dated 12.10.2022.

The appeal is accordingly disposed of.
