**ORDER**

1. The Appellant has filed first appeal on 12.11.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/12258 dated 12.10.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide her application dated 07.10.2022 has requested to provide the certified copies of the CS Executive Examination session June 2022 Subject name 426 Securities Law & Capital Markets. (SLCM).
3. The Appellant has informed in the instant appeals that "Details not provided".
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information on 12.10.2022 in which a web-link, Username and Password has been provided to the RTI Applicant (Appellant hereinafter) to access the answer copies. Further, Upon request of the Appellant, the last date for accessing the Answer Books was extended till 18th November 2022 and the same has been acknowledged by the Appellant vide email dated 16.11.2022."

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. The Office concurs with the submission of the Respondent. It is observed that Appellant has acknowledged the receipt of information sought vide email dated 16.11.2022.

The appeal is accordingly disposed of.
