#### ORDER

- The Appellant has filed first appeal on 05.11.2021 under Section 19(1) of the Right to Information Act, 2005 in connection with query Ref. No. RTI ICSOI/R/E/21/03236 dated 14.10.2021 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 14.10.2021 has requested to provide the certified copies of subjects: 1. Securities Laws & Capital Markets (SLCM) Code-426 2. Economic, Business And Commercial Laws (EBCL) Code-427."
- 3. The Appellant has informed in the instant appeals that "I only received copy of only EBCL. Kindly send me copy of SLCM ASAP."
- 4. The reply of the Respondent against the instant appeal is as under: -

"The requisite information was supplied to the applicant vide email dated 03.11.2021 in which a web-link, Username and Password has been provided to the RTI applicant (appellant herein above) to download and view the answer copies. But, due to technical gap, answer book of SLCM subject was not retrieved by the applicant and the said technical gap was updated and the applicant was once again provided the credentials for retrieval of the information sough vide our email dated 15.11.2021(copy of emails attached).

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. The submissions of the Respondent is taken on record. It is directed that in case, the user name & password as emailed, has not been received, the appellant may approach the respondent within 03 days of issue of this order. It is further directed to the respondent that if approached again the respondent to share the document by email within 7 days of being approached.

The appeal is accordingly disposed of.
