**ORDER**

1. The Appellant has filed first appeal on 09.11.2021 under Section 19(1) of the Right to Information Act, 2005 in connection with query Ref. No. RTI ICSOI/R/E/21/03090 dated 14.10.2021 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 14.10.2021 has requested that "I am not convinced with my marks and hence I wish to put my papers for revaluation/rechecking to get a satisfaction."
3. The Appellant has requested in the instant appeals that "I got my request back saying i have already applied and this one is similar. However these are two different things in the first request i had asked for my answer sheets for my reference which i have received. This one was for reverification or rechecking of my papers by ICSI. I want my papers to be checked again as i am not very convinced with the marks allotted by them hence i had put this request however that has not been addressed to. Kindly put my papers under rechecking."

4. The reply of the Respondent against the instant appeal is as under: -

“This is to inform that we have provided the requisite information/documents in response to RTI Application no. ICSOI/R/E/21/03079 vide Email dated 03.11.2021 in which a web-link, Username and Password has been provided to the RTI applicant (appellant herein) to download and view the answer copies (Copy of email supplying the requisite information is attached herewith and that the receipt of information was confirmed in the instant Appeal. It is further informed that seeking clarifications on your own analysis is not an information under the provisions of the RTI Act, 2005 and hence can not be provided.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. This office concurs with the submission of the respondent that seeking clarifications on your own analysis is not an information under the provisions of the RTI Act, 2005.

The appeal is accordingly dismissed of.
