ORDER

1. The Appellant has filed first appeal on 13.11.2021 under Section 19(1) of the Right to Information Act, 2005 in connection with query Ref. No. RTI ICSOI/R/E/21/04502 dated 20.10.2021 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 20.10.2021 has requested to provide the Photocopy of Answer book.
3. The Appellant has requested in the instant appeals that "Details not provided."
4. The reply of the Respondent against the instant appeal is as under: -
