ORDER

1. The Appellant has filed first appeal on 07.11.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with response Ref. No. RTI 2005/5405(22) dated 11.10.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 12.09.2022 has requested to provide various information related remuneration, travel expenses etc. of President, Vice-President and Secretary of ICSI.
3. The Appellant has informed in the instant appeals that "Refused access to Information Requested".
4. The reply of the Respondent against the instant appeal is as under: -

"The information sought is not maintained in the form/manner as desired and hence not an information within the meaning of the RTI Act, 2005 and as such it can't be provided. Hence, we stand by our RTI reply.

Regarding reply to the query numbers 5:-

Therefore, the appeal deserves to be dismissed in-limine".
