ORDER

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/00478 dated 25.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 04.03.2023 and once again on 17.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the Appellant acknowledged the receipt of the same vide email dated 17.03.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. It has been found that Appellant acknowledged the receipt of the exam copies vide email dated 17.03.2023.
