ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00012 on 09.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/00840 dated 09.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide her application dated 25.02.2023 has requested "to provide the Photocopy of examination held in June 2022. I request ICSI to please provide me the photocopy, in pdf form, of CS Executive (New Syllabus) of the following paper: Module 2 Paper code 426 Securities Laws & Capital Markets (Marks obtained 57 out of 100). Paper code 427 Economic, Business and Commercial Laws (Marks obtained 52 out of 100). Paper code 425 CORPORATE & MANAGEMENT ACCOUNTING (Marks obtained 44 Out of 100) Paper code 428 FINANCIAL AND STRATEGIC MANAGEMENT (Marks obtained 51 Out of 100) Of December 2022.
- (3) The Appellant has informed in the instant appeals that "Details not provided".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/00840 dated 25.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 07.03.2023 and once again on 17.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided to the Appellant to access the information sought vide email dated 07.03.2023 and once again on 17.03.2023 at registered email ID.
