- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00124 on 26.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. - (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Respondent has provided the response to Appellant vide email dated 24.03.2023 & once again on 20.04.2023 & also date extended till 30.04.2023 to access the scanned copies/ information sought. Appellant is requested to check his email id.

The appeal is accordingly disposed of.
