**ORDER**

- (a) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00125 on 26.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/05079 dated 23.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (b) The Appellant vide her application dated 01.03.2023 has requested to provide the certified copies of subjects: JIGL - 421 COMPANY LAW – 422, SBEC – 423.
- (c) The Appellant has informed in the instant appeals that “Refused access to Information Requested”.
- (d) The reply of the Respondent against the instant appeal is as under: -

“1. It is submitted that the information sought has been provided at [shardadangi7@gmail.com](mailto:shardadangi7@gmail.com), the registered email of the candidate concerned, vide email dated 21.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

2. It is further submitted that in the instant Appeal the Appellant is making request for providing the information once again at the email-id not registered with the ICSI and no evidence was placed before the CPIO by the Appellant that the new email-id belonged to the same person i.e. the candidate whose personal information is sought in the aforesaid Appeal and RTI Application. We are to also submit that the personal information of the students/candidates is provided at the registered email-id only.

The contents as above made in the RTI reply stands as it is and are candid”.

- (e) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (f) This Office concurs with the submission of the Respondent. Respondent has provided the response to Appellant vide email dated 21.03.2023 at her registered email id. Further, please note that no information can be provided to Appellant on another email id as personal information of the students/candidates is provided at the registered email-id only.

The appeal is accordingly disposed of.
