Further, the date of accessing the scanned copies has also been extended till 30.04.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Respondent has provided the response to Appellant vide email dated 18.03.2023 & once again on 20.04.2023 & also date extended till 30.04.2023 to access the scanned copies/ information sought. Appellant is requested to check his email id.
