## ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00138 on 28.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/01150 dated 13.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
