ORDER

- (1) The Appellant has filed first Appeal No. ICSOI/A/E/23/00014 on 10.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/22/00736 dated 09.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 25.02.2023 has requested to provide the scanned soft copies of answer book of Executive Programme Examination for the session December, 2022 : Subjects: (01) JURISPRUDENCE AND INTERPRETATION OF GENERAL LAWS (02) COMPANY LAW (03) SETTING UP OF BUSINESS ENTITY AND CLOSURE (04) TAX LAWS
- (3) The Appellant has informed in the instant appeals that "Provided Incomplete, Misleading or False Information".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/00736 dated 25.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 07.03.2023 and once again on 24.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. It has been found that response has been provided by CPIO EXAM to the Appellant on 07.03.2023 & again on 24.03.2023 at his registered email ID.

The appeal is accordingly disposed of.
