ORDER

- (3) The Appellant has informed in the instant appeals that "Details not provided".

(4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/06146 dated 02.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 25.03.2023 and once again on 21.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.
