ORDER

Further, the date of accessing the scanned copies has also been extended till 30.04.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 18.03.2023 and once again on 24.04.2023 & also date extended till 30.04.2023 for accessing the scanned copies. Appellant is requested to check his registered email ID.

The appeal is accordingly disposed of.
