Further, the date of accessing the scanned copies has also been extended till 30.04.2023.

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Respondent has provided the response to Appellant vide email dated 18.03.2023 and once again on 24.04.2023 & also date extended till 30.04.2023 to access the scanned copies/ information sought. Appellant is requested to check her email id.
