**ORDER**

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00016 on 10.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/00867 dated 10.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide her application dated 25.02.2023 has requested "to provide the photocopy of answer book for the CS Executive Examination, session: December 2022, Subject Name (01) 421: Jurisprudence Interpretation and General Laws (02) 422: Company Law (03) 423: Setting Up Of Business Entities And Closure (04) 424: Tax laws.
- (3) The Appellant has informed in the instant appeals that "Refused access to Information Requested".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/00867 dated 25.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 07.03.2023 and once again on 24.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. It has been found that response has been provided by CPIOEXAM to the Appellant on 07.03.2023 & again on 24.03.2023 at her registered email ID.

The appeal is accordingly disposed of.
