## ORDER

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/06813 dated 04.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 28.03.2023 and once again on 24.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.
