- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. It has been found that response has been provided by CPIO EXAM to the Appellant on 09.03.2023 & again on 24.03.2023 at her registered email ID.
