ORDER

- (a) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00174 on 02.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/06281 dated 27.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (b) The Appellant vide her application dated 03.03.2023 has requested to provide the certified copies of answer sheets for CS Professional examination, Session: December 2022 for all subjects of 2nd and 3rd module.
- (c) The Appellant has informed in the instant appeal that "Details not provided".
- (d) The reply of the Respondent against the instant appeal is as under: -
 - "1. It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/06281 dated 03.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 27.03.2023 and once again on 27.04.2023 in which a weblink, Username and Password have been provided to the Appellant to access the information sought.
 - 2. It is further submitted that in the instant Appeal the Appellant is making request for providing the information once again mentioning the email-id other than that of the email-id registered with the ICSI and no evidence was placed before the CPIO by the Appellant that the new email-id belongs to the same person i.e. the candidate whose personal information is sought in the aforesaid Appeal and in the RTI Application. We are to also submit that the personal information of the students/candidates is provided at the registered email-id only.

The contents as above made in the RTI reply stands as it is and are candid".

- (e) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (f) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant vide email dated 27.03.2023 and once again on 27.04.2023 at her registered email id. Further, Information sought can be provided to Appellant at her registered email id only.

The appeal is accordingly disposed of.
