 - 2. It is further submitted that the Appellant has now provided the requisite credentials in this instant Appeal and thus, the CPIO is of the view that the information sought can be provided and hence the information sought has been provided to the Appellant vide email dated 28.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

The contents as above made in the RTI reply stands as it is and are candid".

- (e) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (f) This Office concurs with the submission of the Respondent. Respondent has provided the response to Appellant vide email dated 28.04.2023 to access the scanned copies/information sought. Appellant is requested to check her email id.

The appeal is accordingly disposed of.
