- (2) The Appellant has filed first Appeal No. ICSOI/A/E/23/00018 on 10.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/22/01034 dated 09.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (3) The Appellant vide his application dated 25.02.2023 has requested to provide the photocopy of answer book of Professional Programme Examination for the session December, 2022 : Subjects: (01) Governance Risk Management Compliance and Ethics (GRMCE) 431 (02) Advance Tax 432 (03) Drafting pleading and appearance 433 (04) Corporate funding 437 (05) Multi Disciplinary case study (MCS) 438 (06) ILP 448.
- (4) The Appellant has informed in the instant appeals that "Details not provided".
- (5) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/01034 dated 25.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 09.03.2023 and once again on 24.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

The contents as above made in the RTI reply stands as it is and are candid".
